




ELECTRONIC INSPECTIONS BUILDING REPORTS

CONCEPTUAL ENGINEERING

The basic parameters of design are defined to identify protection alternatives and to estimate the characteristics of the project.

An acceptable level of safety is identified against fires for the project and its analyzed, they evaluate and select the different applicable alternatives of fire protection.






ANALYSIS OF OFFERS AND SELECTION OF SUPPLIERS






LIFE SAFETY ANALYSIS

PROOF OF ACCEPTANCE EQUIPMENT

To check the behavior of the bomb on a variety of conditions in order to evaluate which would be the performance of the installation in an eventual emergency.
